# CONTRACT FOR THE RENOVATION OF DEPARTMENT OF FINANCE 8TH FLOOR EDPC BUILDING

THIS AGREEMENT, made this \_\_\_\_\_ day of \_\_\_\_ 2022 between the DEPARTMENT OF FINANCE, a government agency created and existing by authority of Executive Order Nos. 127-A and 292, with principal office at DOF Building, Bangko Sentral ng Pilipinas Complex, Roxas Boulevard, Manila (hereinafter called "the Entity") of the one part, and R.M. MANGUBAT CONSTRUCTION, a sole proprietorship duly organized and existing under the laws of the Republic of the Philippines, with office address at of G/F Blk. 1 Lot 6 Doña Manuela AvenueDoña Manuela Subdivision, Pamplona 3,Las PiñasCity (hereinafter called "the Contractor") of the other part;

WHEREAS, the Entity is desirous that the Contractor execute the Renovation of the Department of Finance 8th Floor EDPC Building and the Entity has accepted the Bid for the sum of Eighty-Six Million Six Hundred Seventy-Seven Thousand Four Hundred Twenty-Six Pesos and 79/100 (\$\bar{P}86,677,426.79)\$ by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings asare respectively assigned to them in the Conditions of Contract hereinafter referred to.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

Performance Security;

Notice of Award of Contract; and the Bidder's conforme thereto; and

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as

The PARTIES shall implement security measures aimed at maintaining the availability, integrity, and confidentiality of personal data including the protection of personal data against any accidental or unlawful destruction, alteration, and disclosure, as well as against any other unlawful processing.

# 6. Consent to the Processing of Personal Information

As part of the data privacy compliance, the Contractorhereby grants its consent to the Entity's processing of its personal information collected under this contract, which may include the disclosure of such information to third parties, to comply with requirements of law in relation to the implementation of this contract.
