# CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS SUPPLIES IN THE DEPARTMENT OF FINANCE

LOT 2 – CLEANING SUPPLIES IB No. 2024-09-G

THIS AGREEMENT made the \_\_\_\_\_ day of \_\_\_\_\_ 2024 between **DEPARTMENT OF FINANCE** of the Philippines (hereinafter called "the DOF") of the one part and **CENTER POINT SALES AND TRADING INC.** of 6<sup>th</sup> Floor Unit 604 Sky 1 Tower Bldg., No. 68 Dasmariñas St., Binondo, Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the DOF invited Bids for the Supply and Delivery of Various Supplies in the DOF – Lot 2 Cleaning Supplies and has accepted a Bid by the Supplier for the supply of those goods in the sum of Seven Hundred Seventy-Seven Thousand Seven Hundred Seventy-Seven Pesos (₱777,777.00) (hereinafter called "the Contract Price").

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
  - A. Philippine Bidding Documents (PBDs);
    - a. Schedule of Requirements;
    - b. Technical Specifications;
    - c. General and Special Conditions of Contract; and
    - d. Supplemental or Bid Bulletins, if any
  - B. Supplier's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - C. Bid form, including all the documents/statements contained in the Supplier's bidding envelopes, as annexes, and all other documents submitted (e.g., Supplier's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from DOF's bid evaluation;
  - D. Performance Security;
  - E. Notice of Award of Contract; and the Supplier's conforme thereto; and
  - F. Other contract documents that may be required by existing laws and/or the DOF in the PBDs. The Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of Seven Hundred Seventy-Seven Thousand Seven Hundred Seventy-Seven Pesos (₱777,777.00), Center Point Sales and Trading, Inc. shall provide the Supply and Delivery of Various Supplies in the DOF Lot 2 Cleaning Supplies in accordance with its Bid.





4. The **DEPARTMENT OF FINANCE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

## 5. Data Privacy Compliance

The PARTIES shall comply with the provisions of Republic Act (RA) No. 10173, otherwise known as the "Data Privacy Act of 2012", its Implementing Rules and Regulations (IRR), issuances of the National Privacy Commission (NPC), and other applicable laws on processing of personal information. These shall include compliance with all relevant data protection policies of the Entity and other measures reasonably necessary to prevent any use or disclosure of personal data other than as allowed under this contract.

The PARTIES shall implement security measures aimed at maintaining the availability, integrity, and confidentiality of personal data including the protection of personal data against any accidental or unlawful destruction, alteration, and disclosure, as well as against any other unlawful processing.

## 6. Consent to the Processing of Personal Information

As part of the data privacy compliance, the Supplier hereby grants its consent to the DOF's processing of its personal information collected under this contract, which may include the disclosure of such information to third parties, to comply with requirements of law in relation to the implementation of this contract.
