

**CONTRACT FOR THE PROCUREMENT OF ADDITIONAL 25 UNITS
COMPUTER MONITORS THROUGH REPEAT ORDER**

THIS AGREEMENT made the _____ day of JAN 22 2025 2025 between **DEPARTMENT OF FINANCE** of the Philippines (hereinafter called "the DOF") of the one part and **JONECO TECH MARKETING CORP.** of No. 7 Pioneer St. corner Sheridan St., Elena Roces Compound Highway Hills, Mandaluyong City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Department of Finance requires a proposal for the procurement of an **additional 25 units of computer monitors** and has accepted a proposal from the supplier for the supply of these goods at a total cost of **Four Hundred Eighty-Seven Thousand Five Hundred Pesos (₱487,500.00)** (hereinafter referred to as "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, terms and expressions shall have the same meanings as assigned to them in the Conditions of Contract referenced herein
2. The following documents, as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, shall be considered an integral part of this Agreement and shall be read and construed accordingly:
 - A. Purchase Request and Justification;
 - B. BAC Resolution;
 - C. Bid Proposal and Confirmation Letter;
 - D. Notice of Award of Contract; and the Supplier's conforme thereto; and
 - E. Other contract documents that may be required by existing laws and/or the DOF in the PBDs. The Supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the sum of **Four Hundred Eighty-Seven Thousand Five Hundred Pesos (₱487,500.00)**, **JONECO TECH MARKETING CORP.** shall supply an **additional 25 units of computer monitors** in accordance with its proposal.
4. The **DEPARTMENT OF FINANCE** agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
5. **Data Privacy Compliance**

The PARTIES shall comply with the provisions of Republic Act (RA) No. 10173, otherwise known as the "Data Privacy Act of 2012", its Implementing Rules and Regulations (IRR), issuances of the National Privacy Commission (NPC), and other applicable laws on processing of personal information. These shall include compliance with all relevant data protection policies of the Entity and

other measures reasonably necessary to prevent any use or disclosure of personal data other than as allowed under this contract.

The PARTIES shall implement security measures aimed at maintaining the availability, integrity, and confidentiality of personal data including the protection of personal data against any accidental or unlawful destruction, alteration, and disclosure, as well as against any other unlawful processing.

6. Consent to the Processing of Personal Information

As part of the data privacy compliance, the Supplier hereby grants its consent to the DOF's processing of its personal information collected under this contract, which may include the disclosure of such information to third parties, to comply with requirements of law in relation to the implementation of this contract.
